

number of facts is too limited to give them a concrete basis for the general ideas which make up the chief part of the book.

On the other hand, the book possesses merit in that few works, if any, set forth so clearly and simply some of the more important aspects of Roman history. Students would surely benefit from reading it along with such manuals as Boak's, Frank's or Heitland's.

The author seems to be accurate, but one curious slip cannot be allowed to pass unnoticed. On page 185 he states, "Augustus died about five years before the birth of Christ", whereas the accepted date of his death is 14 A.D.
