

**Gretchen Bakke** is an anthropologist whose work focuses on contemporary art and cinema as embedded cultural products. She is currently a postdoctoral fellow at the Center for the Humanities, Wesleyan University, where she is working on two book projects: “Self in Slovene Society” and “Slovenia and the Art of Failure.” Her most recent publication (on American action heroes) is “Continuum of the Human” in *Camera Obscura* 22 (2007): 60–91.

**Aleš Gabrič** is a research fellow at the Institute of Contemporary History in Ljubljana and a professor of Slovene cultural history at the University of Ljubljana. His research interests are cultural policy, history of education, and relations between the communist authorities and intellectuals. His most recent book is *Šolska reforma 1953–1963*.

**Irena Gantar Godina** is assistant professor of history specializing in Slovenia and Southeastern Europe at the turn of the twentieth century. Currently she is working as a research adviser at the Institute for Slovenian Emigration Studies SRC SASA. Her area of research is Slovene intellectuals who emigrated to other Slavic countries before 1918.

**Klaus-Jürgen Hermanik** is research fellow at the Department of History (Centre for Southeast-European History) at the University of Graz. His monograph *Eine versteckte Minderheit*, on the hidden Slovene minority in Austrian Styria, appeared in 2007. His current research project, “Identity Management of the Germans and Hungarians in Southeastern-Central Europe,” is on the two ethnic groups in Slovenia, Slavonia, Vojvodina, southwestern Hungary, and Transylvania.

**Boris Jesih** is a senior research fellow at the Institute for Ethnic Studies (Ljubljana) and a faculty member at the University of Primorska. He has published extensively in ethnic studies and in particular on the Slovene minority in Austria. He is editor-in-chief (1990–) of *Ethnic Studies/Treatises and Documents* and is a member of the Slovene-Austrian Expert Commission, dealing with the relations between the two states.

**Darja Kerec** is an instructor at the University of Ljubljana’s Faculty of Education. Her research interests include regional and cultural Slovene history. Among her recent articles is a historical survey in *Slowenien*, by Dušan Nečak and Božo Repe (2006).

**Matjaž Klemenčič** is professor of history at the University of Maribor and teaches at the University of Ljubljana and Primorska University. In fall 2008 he is a visiting professor at Colorado State University-Pueblo. He is directing a research project on Slovene immigrants at the Institute for Ethnic Studies (Ljubljana) and will direct an interdisciplinary project on

Slovenes in contact with other “nations.” He is the author or co-author of six books.

**Alenka Koron** is a research fellow and librarian at the Institute of Slovene Literature and Literary Studies in Ljubljana. Her interests include contemporary methodology of literary scholarship, narrative theory, and the theories of fiction and autobiography. She is currently writing a history of narratology and its recent development.

**Robert Gary Minnich** is associate professor emeritus of social anthropology at the University of Bergen. He has published widely on diverse aspects of identity management and state formation among Slovene speakers in Austria and Italy.

**Božo Repe** is a full professor of modern history at the University of Ljubljana. His research interests are twentieth-century Slovene, Balkan, and Central European History. He has published more than 150 articles in Slovenia and abroad and eighteen books and textbooks. He has lectured at various European universities and served as head of the Department of History at the University of Ljubljana’s Faculty of Arts.

**Mitja Velikonja** is an Associate Professor of the sociology of culture at the University of Ljubljana and research fellow at the Centre for Cultural and Religious Studies, School of Social Sciences. His research interests are Central-European and Balkan religious, national and cultural processes and political mythologies, and popular culture. He is the author of five books and numerous other publications.

**Alojzija Zupan Sosič** is a faculty member in the Department of Slovene Studies at the University of Ljubljana. She has published widely on comparative literature, narrative theory and genres, and gender theory and identity. Her most recent book on the Slovene novel is *Robovi mreže, robovi jaza: Sodobni slovenski roman* (2006).

**Jernej Zupančič** is associate professor in the Department of Geography, University of Ljubljana. He has over two hundred publications on ethnic issues, minorities, border landscapes, Southeastern Europe, crisis areas, and international migrations, including the book *Slovenci v Avstriji*. He recently completed the research project “Developmental Opportunities of Slovene communities in Neighboring Countries.”
