THEODORE BUILA is an Associate Professor of Occupational Education at Southern Illinois University, Carbondale. His specializations include agricultural development, rural employment, and technical education. He was a Fulbright Fellow in 1966/67 and a Visiting Professor at the Biotechnical Faculty, Ljubljana, during 1971/72. Currently he is the director of a 5-year field study to document the economic and social impact of physical communications in isolated Slovene villages.

ROBERT G. DYCK is Professor of Environmental and Urban Systems at Virginia Polytechnic Institute and State University and has served as Director of the University's International Programs since 1976. His professional interests lie principally in the areas of regional development planning and administration, including health planning. ALEŠ L. LOKAR is Professor at the Economic Faculty of the University of Urbino, Italy, and Editor of the review *Most* (Trieste). He is the author of articles dealing with social and economic aspects of the development of the Slovenes. His research interests include the economic relations between Italy and Yugoslavia.

BOGDAN C. NOVAK is Professor of Central European (Habsburg) and Russian History at the University of Toledo. His book *Trieste 1941-1954: The Ethnic, Political and Ideological Struggle* (Chicago, 1970) was translated into Italian in 1973 and covers his major field of interest. He has also written numerous articles in this field, in both Slovene and English, and in Slovene history in general.

DAVID F. STERMOLE is Sessional Lecturer in the Department of Anthropology at The University of Alberta, Edmonton, Canada. He received his Ph.D. in Anthropological Linguistics from the University of Toronto in 1977. His main fields of interest include bilingualism, dialectology, and sociolinguistics.

RUDOLPH M. SUSEL was Assistant Professor of History at Arizona State University from 1970 to 1976. His principal fields of interest are Balkan and East European History and the history of Slovene Americans. He served as Managing Editor for Yugoslavia for the academic journal *Southeastern Europe* and is principal editor of *Papers in Slovene Studies* 1977. He also is the author of the article on the Slovenes for the projected Harvard Encyclopedia of American Ethnic Groups

LEE THOMAS is an Instructor at the University of New Orleans and a Ph.D. candidate at Tulane University. His areas of specialization are microeconomics and econometrics. His most recent publication is "An Empirical Test of the Relationship Between Market Concentration and Vertical Integration," which is forthcoming in the *Industrial Organization Review*. IRENE PORTIS WINNER is an Associate Professor of Anthropology at Emmanuel College and a Visitor at the Russian Research Center, Harvard University.
