The authors of articles and of translations in this volume are as follows:

NATAŠA BENKIČ, KATARINA JERIN and NIKE KOCIJANIČIČ belong to a privately-organized group of literary translators working in Ljubljana. Benkič is a student of English and the Sociology of Culture; Jerin, a student of English and Comparative Literature; and Kocijančič, a student of English and French.

IVAN BOH is Professor of Philosophy, The Ohio State University, Columbus. He specializes in medieval philosophy and the history of logic. He has written 37 studies, especially on epistemic logic in the 14th and 15th centuries; and has translated from the Latin and edited nine treatises on logic.

CATHERINE D. CARMICHAEL is currently preparing a dissertation, on the Historical Anthropology of the Slovene Peasantry in the 17th and 18th centuries, in the Research Unit in South East European Studies, University of Bradford, England. During the academic year 1989-1990 she received a British Council Scholarship to study in the Department of History, Ljubljana University.

HENRY R. COOPER, JR., is currently Acting Dean for International Programs, Indiana University. His areas of research include Medieval Russian Literature, South Slavic Literatures, and Bible translations in Slavic and East European languages. His most recent major publication is *Judita*, a translation from Croatian to English (Boulder CO: East European Monographs).

FRANE JERMAN, Professor of Philosophy at the University of Ljubljana, has, as his most important firelds of research, logic, and the history of Slovene philosophy. He is also interested in esthetic subjects. Among his publications are *Med logiko in filozofijo* (1971), *Iz filozofije znanosti* (1976), *Sprehodi po estetike* (1978) and *Filozofija* (1992).

IGOR MAVER is Assistant Professor of English and American Literature at the University of Ljubljana. His areas of research include American ethnic and southern literature, Australian literature, English literature, and cross-cultural studies, and he has many publications in these areas.

JERNEJA PETRIČ is Assistant Professor of American Literature at Ljubljana University. Her main areas of research are Slovene-American literature and contemporary American literature. Her publications include an anthology of Slovene-American and Slovene-Canadian literature and studies on Louis Adamic.

MATJAŽ POTRČ is Professor of Logic and Methodology at Ljubljana University. He is currently involved in a project on phenomenological tradition and cognitive science, with the twofold aims of placing Slovene philosophy in its European context and establishing a Chair in Cognitive Science at Ljubljana University.

ANDREJ VOVKO is former Head of the Inštitut za slovensko izseljenstvo pri Znanstveno-raziskovalnem centru SAZU. and editor-in-chief of Two Homelands: Migration Studies. His current research deals with contacts between Slovene emigrants and Slovenia, and with Slovene political emigration after WW II.

JANJA ŽITNIK received her doctoral degree from the University of Ljubljana in 1991. She is Senior Researcher and current Head of the *Inštitut za slovensko izseljenstvo pri Znanstveno-raziskovalnem centru SAZU*. For the last six years she has been engaged in research into Slovene émigré literature, particularly the last period of Louis Adamic's life and work.
